## 2. Doctoral Program

Our three-year PhD program is organized around a number of compulsory activities and non-compulsory training. You may find it helpful to discuss how to prioritize them with your supervisor and colleagues.

### 2.1. Research Proposal (Exposé)

#### *First-Year Activity*

Within the first year of doctoral study, researchers should (among other things) prepare a written research proposal/exposé, which will be the base for a public presentation at the department. The purpose of the proposal is to give a good impression of the research to be expected, determine the goals, lend the project some context, and provide a roadmap for its successful and timely completion. ## Modalities of Exposé in Philosophy:

Decide which type of exposé is most appropriate for you and your project, taking into account the advice of your supervisor.

### Modality 1

Submit a **long research proposal** (approximately 3,000-5,000 words) that includes the following items:

- Description of the topic of the dissertation project, including a clear research question
- Outline of the state of the research
- Explanation of the chosen research methods
- Relevant literature
- Choice of supervisors
- Time and work schedule, possibly financial budget and overview of resources

### Modality 2

Submit a **brief research proposal** (approximately 1,000 words) that includes a condensed version of the items listed in modality 1 **and a piece of research** (no longer than 5,000 words). The research paper must

- be a self-contained piece of academic research written during the first year of studies
- be thematically related to the research proposal
- Illustrate the type of work to be undertaken in the research phase of the PhD.



## 2.2. Faculty Presentation (FÖP)

### *First-Year Activity*

Before the end of the first year, a doctoral researcher must give a public presentation based on the research proposal: the so-called FÖP (**F**akultäts**Ö**ffentliche **P**räsentation). In some cases, the timeframe may vary (e.g. for part-time/self-funded researchers).

The FÖP allows Director of Doctoral Studies to approve the continuation of your doctoral studies for the next three years. The FÖP is an opportunity to present your research projects to other members of the department, receive feedback, and engage in constructive discussion of key aspects.

### **Formal requirements:**

- Max. 10 minutes presentation
- 20 minutes discussion/questions
- Presentations can be in English or German

## Recommendations:

## 2.3. Doctoral Thesis Agreement

### *First-Year Activity*

After the public presentation, a dissertation agreement is made between the doctoral student, the supervisor(s), and the University (signed by the Director of Doctoral Studies on behalf of the Studienpräses). This agreement formalizes the obligations and responsibilities of each party. More information is available at

## Recommendations:

- Register a second supervisor in your doctoral thesis agreement.
- Arrange a thesis advisory committee for your project.





## 2.4. Monographs and Cumulative Dissertations

Doctoral students must decide whether their work will take the form of a monograph or a cumulative thesis (i.e., a collection of papers). This should be discussed with supervisors/dissertation advisory committees and decided by the second year. (In some cases, timescales may vary, e.g., where researchers are part-time/self-funded).

It is a good idea to begin drafting dissertation chapters as soon as possible, with the goal of completing the entire dissertation by the end of the third year. If a fourth year is available, it may be used for final editing and preparation for the defense.

If you are preparing a cumulative dissertation, please read the VDP guidelines on cumulative dissertations in philosophy available on our moodle.

## 2.5. Coursework and Recognition of Examinations

The doctoral program in philosophy at the University of Vienna also includes a continuing education component in the form of doctoral seminars, participation in conferences and summer schools in the amount of 24 ECTS points. At least 15 of the 24 ECTS points have to be obtained in doctoral seminars.

Students may enroll in doctoral seminars from the beginning of their studies, e.g. to prepare their Exposé and FÖP.



The purpose of the doctoral seminars is twofold: first, to broaden philosophical expertise; and second, to practice presenting and discussing original ideas.

## 2.6. Annual Reports

### *Second- and Third-Year Activity*

Doctoral students are required to submit a progress report each year after passing the FÖP. Annual progress reports serve two purposes:

First, they take stock of the progress made during each year of the doctoral program. This may sound trivial, but it helps both doctoral candidates and their supervisors to keep track of their doctoral projects and to avoid pitfalls that, in retrospect, could have been easily avoided (e.g., unrealistic timetables, procrastination, etc.).

Second, the annual reports can document changes that become necessary or even desirable during the course of the doctoral studies that could not have been foreseen when the dissertation agreement was signed. For example, if the



original plan involved some specific data collection, this aspect may become impossible because access to special archives or data sets has been denied. Or new opportunities may arise, such as a new conference or workshop on the topic of the dissertation project. These changes to the dissertation agreement must be documented in the annual reports. It is important to emphasize that it is ultimately up to the Director of the Doctoral Studies to accept these changes. Further information can be found at

## 2.7. Thesis Submission and Defense

### *Third Year Activity*

Doctoral researchers are asked to nominate individuals to serve as examiners for their dissertation. Please note that reviewers cannot be supervisors or members of the thesis advisory committee and must be external to the University of Vienna. It is a good idea to identify potential examiners already in your second or third year. Please discuss this with your supervisor(s)/dissertation advisory committee.

## 3. Supervision and Career Development

### 3.1. Co-Supervision

It is often a good idea to have two supervisors. Please note that supervisors cannot serve as examiners for the final dissertation.

Doctoral researchers are expected to work closely with their supervisor(s) throughout their doctoral studies. It is strongly recommended to have a supervisory meeting at least once a month. Beyond that, it is largely up to the individuals involved to decide how best to work together. Once agreed, working arrangements should be kept under review and adjusted as necessary.

The Code of Good Practice sets out the core responsibilities of supervisors and doctoral students (see §4 above). The Doctoral Thesis Agreement further strengthens these arrangements (see §9 below).

### 3.5. Teaching

It is an excellent idea to gain teaching experience during the PhD, and this will be important for a career in academic philosophy. VDP researchers employed as university assistants are required to teach a certain amount of undergraduate courses. Other doctoral researchers are invited to apply for teaching opportunities. It is important to balance teaching and research commitments carefully.

Before teaching for the first time at the University of Vienna, it is necessary to complete the basic qualification:

### 3.6. Publications

VDP researchers are encouraged to publish the results of their research. Ideally, this involves submitting articles for publication in peer-reviewed academic journals. It may also involve submitting a monograph for publication as a book upon completion of doctoral research. The development of a research career in philosophy revolves centrally around publication.

The peer-review process often takes a long time. So it may be a good idea to start submitting research articles already during the doctoral studies, if substantial and publishable results have been obtained. But one should avoid premature publication of material – so it is essential to consult the supervisor/advisory committee for advice on this matter. You may even want to develop a publication strategy.

Apart from your own timing, another essential aspect of publishing is the target venue. Publication venues vary



widely in scope, prestige, acceptance rate, and turnaround time. If you are considering submitting a paper, it is recommended that you discuss this with your supervisor to receive advice on where to submit. In any case, please be careful to avoid predatory publishers.
